Installing NerveCenter on UNIX

Component	Description
NerveCenter Client	Lets you monitor your network, as well as design and manage behavior models.
NerveCenter Administrator	Lets you configure NerveCenter.
NerveCenter Server	Carries out all major tasks, including polling SNMP agents, triggering alarms, and making sure that alarm transitions occur.
Platform Adapters	Integrate NerveCenter with supported network management platforms. (See the <i>NerveCenter 4.0.3 Release Notes</i> for a complete list.)
NerveCenter Web support	Integrates NerveCenter with supported Web servers. (See the <i>NerveCenter 4.0.3 Release Notes</i> for a complete list.)
Online documentation	Provides the NerveCenter library in HTML with a full-text search engine. (PDF versions are also installed for printing.)

Preparing to Install NerveCenter on UNIX

Before you install NerveCenter, you must set up the environment by backing up existing NerveCenter files, stopping processes, creating users and groups, and configuring services.

📎 Note

You cannot install multiple versions of NerveCenter on the same machine. Only one version can be installed on a machine.

Before you prepare the machine, make sure you meet the prerequisites in Table 2-2:

TABLE 2-2. Prerequisites for Installing NerveCenter on UNIX

TABLE 2-2. Prerequisites for Installing NerveCenter on UNIX (Continued)

TO SET UP YOUR MACHINE

- 1. On the system where you plan to install Open NerveCenter, log in as root.
- 2. If NerveCenter is already installed on this machine, stop all NerveCenter and Wind/U processes. See *Upgrading NerveCenter*.

If any of these processes are still running when you start the installation script, the script will quit and display a list of the processes you must stop. Once you have stopped the processes, you can rerun the script.

- **3.** If NerveCenter is already installed on this machine, back up any files that you have customized for your business or your environment. See *Upgrading NerveCenter*.
- 4. You must uninstall NerveCenter before installing NerveCenter 4.0. See *Removing Open NerveCenter* on page 83 or *Upgrading NerveCenter*.
- 5. If the following two groups don't already exist, create them: ncadmins and ncusers.

CAUTION

Do not create these groups on the NIS client machine. If you do, you will not be able to log in to the NerveCenter Server on that machine.

6. Create a new user, **nervectr**, that is a member of the group neadmins.

NOTE

Create the nervectr user in the NIS database if the machine running the NerveCenter Server is using NIS for user authentication.

- **7.** If you are installing NerveCenter on HP-UX, make sure that HP Services is configured to search both /etc/services and NIS by doing the following:
 - a. Run sam and choose Network and Communications.
 - b. Choose Name Service Switch.
 - c. Make sure the services line includes entries for NIS and /etc/services.

- d. Select the **services** line.
- e. Right click the services line and select Configure Name Service Switch.
- f. In the window displayed, set If Information is Not Found to Try Next Source.
- **8.** If you are installing NerveCenter on HP-UX, make sure the kernel parameter, nfile, is set to at least 1000 to allow more open files:
 - a. Run sam and choose Kernel configuration.
 - **b.** Then choose **Configuration parameters**.
 - c. Set nfile to at least 1000.
- **9.** If you are installing NerveCenter on HP-UX, make sure the kernel parameter, maxfiles, is set to at least 200:
 - a. Run sam and choose Kernel configuration.
 - **b.** Then choose **Configuration parameters**.
 - c. Set maxfiles to at least **200**.

Once you have finished configuring the system, you can install NerveCenter.

Running the Installation Script (Interactive)

The installation script prompts you with a series of questions. You can:

- Press Enter to accept the default value (displayed between brackets []).
- Enter **y** for yes, **n** for no, or **q** to quit the installation.
- Enter a question mark (?) to get help.
- Type **Ctrl+c** to terminate the installation immediately.



When you are prompted for the name of a directory, you must enter the full path name. Characters such as the tilde (~) are not recognized.

If an error occurs during the installation process, the script will tell you what to do.

TO RUN THE INSTALLATION SCRIPT

- 1. If you haven't done so already, shut down all NerveCenter processes.
- **2.** Mount the NerveCenter CD-ROM.
- 3. Navigate to *mountpoint*/**BIN**.
- 4. Enter the following command:

./INSTALL.SH



On HP-UX, type ./INSTALL.SH\;1.

The script begins to run.

5. At the following prompt, press Enter to accept the default installation directory or enter a new one.

Where do you want to install NerveCenter? [/opt/OSInc]



If you are installing over an existing /opt/OSInc directory, the install script backs the existing files up to /opt/OSInc.sav.

6. If the directory does not already exist, answer **y** to the following prompt:

Directory /opt/OSInc doesn't exist.....Shall I create it ?
[y]

7. Type the letter for each component you want to install (separating each one with a space), then press Enter.

Letter	Component	Notes	
с	Client	Install if you want to be able to monitor the network and create or modify behavior models from this system. No other NerveCenter components have to be installed on this system.	
W	Web server integration	Install if you want to be able to use the Web Client from any system connected to the network. We recommend that you install this component on the system on which the web server is installed; however, doing that is not required.	
a	Administrator	Install if you want to be able to customize NerveCenter from this system. No other NerveCenter components have to be installed on this system.	
S	Server	Install if you want to have the main NerveCenter pieces, including the NerveCenter database and other primary files, located on this system.

NOTE

The script will quit if any of the following conditions are true: you did not create the required users and groups, there is not enough space in this directory, some NerveCenter processes are still running. Correct the condition (create the users, create some more space, or stop the processes) and rerun the installation script. See *Preparing to Install NerveCenter on UNIX* on page 10 for details.

The script lists each file as it is extracted.

If you are installing the OpenView integration, be sure to go to *Additional Step for First-time, OVPA-only Installs* on page 21 and follow the additional instructions if you are running NIS.

8. At the following prompt, press Enter to accept the default path or enter a different path.

Enter the path of the X motif libraries. [/usr/dt/lib]

9. If the installation script indicates that you need to update the services file, type **y** and then press Enter at the following prompt. Otherwise, just press Enter.

Do you want to update the services file ? [n] n

10. At the following prompt, type your license key and press Enter.

Enter the license Key []

📎 Note

If you leave the license key empty, you can start the server and connect to it from the administrator to add the key later. If you have multiple keys, enter one here and use importutil or the administrator to add the others later.

11. If you are installing platform integration for OpenView, press Enter. If you are not, skip to the next step.

Do you wish to configure NerveCenter integration with OpenView on this system ? [y]

12. At the following prompt, press Enter if you are not running co-resident. If you are running both NerveCenter and HP OpenView on this system, type **y** and press Enter.

Will you be running NerveCenter co-resident with OpenView on
this system?

```

13. At the following prompt, type the full path and executable name of your HTML browser (/usr/netscape/netscape, for example).

CAUTION

If you do not enter a path to a browser, you will not be able to view the NerveCenter Help. For a list of supported browsers, see *Software Requirements* in *NerveCenter 4.0.3 Release Notes*.

Enter the path and the name of your browser : [.]

 At the following prompt, press Enter to configure the server so you have to start it manually. To configure the server as a daemon so it starts automatically when you reboot the system, type y and press Enter.

You can start NerveCenter server as a daemon. If you do, NerveCenter server will start automatically when you reboot the system. Enter your choice [y]

15. At the following prompt, press Enter to configure web server integration.

```
Do you want to configure web server integration ?
Enter your choice [y]
```



If your Web server is on a different machine, you must configure the Web server yourself. See *Managing NerveCenter Web Integration* in *Managing NerveCenter* for details.

16. At the following prompt, type the appropriate number for the web server with which you want to integrate NerveCenter. Then, press Enter.

Please enter the web server : [1]

- **17.** If you are installing web integration, follow the prompts to configure your web server. For example, to integrate NerveCenter with Apache, do the following when you are prompted:
 - **a.** Enter the path to the Apache web server configuration directory (the directory containing httpd.conf and srm.conf).
 - **b.** Enter the path to the Apache web server pid file location.
 - c. Confirm that you want the installation script to modify the Apache configuration file.

The script backs up the original file in the /apache/conf directory as srm.conf.NCbak.

d. Decide whether you want to restart the web server now. (If not, remember to do so later.)

- e. Decide whether to configure NerveCenter webcollector as a daemon to start when the system reboots.
- If you are installing the universal platform adapter for integration with Micromuse Netcool/OMNIbus or Tivoli TME, the following prompt lets you specify whether to install it as a daemon.

You may choose to start NerveCenter PA Server at system startup. Choosing to do so will bring up the NerveCenter PA Server when the system boots the next time. Enter your choice [n]

19. When the installation script finishes, source the appropriate ncenv shell script in /opt/OSInc/userfiles for the shell you are running.



You must source this file to be able to run NerveCenter. Add the lines from these files to the login scripts for all users who are going to be starting NerveCenter applications on UNIX.

You have installed NerveCenter.

Running the Installation Script (Automatic)

If you want to install NerveCenter without having to answer each prompt one at a time, you can modify the ncinput file provided with NerveCenter and run the install script so it uses that file to get your answers.

TO RUN THE INSTALLATION SCRIPT

- 1. If you haven't done so already, shut down all NerveCenter processes.
- 2. Mount the NerveCenter CD-ROM.
- 3. Navigate to *mountpoint*/bin.
- 4. Copy ncinput to your local system.
- 5. Open **ncinput** in a text editor.
- 6. Edit **ncinput**, using the examples in the file as a guide.



You can delete sections or options that do not apply to the components you are installing or for which you want to accept the defaults; however, some options are required. If you delete those options, your installation will fail.

Table 2-4 describes the sections in the input file. Also refer to *Running the Installation Script* (*Interactive*) on page 14 for more detailed explanations of the various options.

Additional Step for First-time, OVPA-only Installs

For a first-time, OVPA-only install, users must add one or both of the following two lines to their local /etc/services file (or the /etc/services file on the NIS server, if running NIS):

nl-nc-opc-adapt 6028/tcp nl-nc-plat-adapt 6024/tcp

The first line applies to Operations Center and ITO adapters. The second line applies to OpenView platform adapters. Editing the services file requires root privileges on the host platform.

If you are making these changes on an NIS server, you will need to run 'make services' from the /var/yp directory to push the changes out to NIS clients.

These entries tell the platform adapters which TCP port to open for communications with NerveCenter Servers. If the required entry or entries is absent, the platform adapter will exit on startup with an Accept Socket Error.

Viewing the Installation Log

If you need to troubleshoot the installation or if you just want to review what options you specified, you can view the installation log. The installation log contains the full installation script, your answers, and the list of files that were installed.

TO VIEW THE LOG FILE:

Setting Up the Database on Windows

When you install NerveCenter for the first time or move the NerveCenter database to a new location, you must either set up a new NerveCenter database or reconnect to an existing NerveCenter version 4.0 database. (If you are upgrading, refer to *Upgrading NerveCenter*.)



You cannot connect to a NerveCenter 3.8 database without first upgrading it to version 4.0. If you are upgrading from NerveCenter 3.8, you must upgrade your NerveCenter database to version 4.0. Refer to Upgrading NerveCenter for more information.

If you instructed NerveCenter Setup to set up your NerveCenter database, then DBWizard is automatically launched for you after NerveCenter Setup is done.

If you create a new database, you can use either a Microsoft Access database or a Microsoft SQL Server database. As part of the creation process, a serialized database file is imported into the database. The serialized file contains the base set of NerveCenter objects, including polls, masks, alarms, and so on.



You do not need to have Access installed on the machine to create an Access database.

Creating and Installing a New Database

Open NerveCenter supplies a wizard called DBWizard and a command-line version of the wizard. You can use either one to set up your database. If you are installing NerveCenter on many computers, you may want to use the wizard to set up the first database, then save your configuration settings and use them with the command-line version of DBWizard to save time on subsequent setup routines.

If you are creating a SQL database, you must be logged into the same domain that SQL Server is running on and you must have SQL administrator (sa) rights, including the right to create database devices.

Doing Silent and Remote Installations on Windows

A *silent installation* is an installation done from the command line. In a text file, you provide all the configuration values that you would normally enter in the Setup GUI. A *remote installation* is done using Microsoft Systems Management Server (SMS) tools.



Remote installations can only be performed on a Windows Server. Windows Workstation is not supported by SMS 1.x for this type of installation.

The procedures for both are very similar—remote installations using SMS include one additional step. The following steps describe the procedure:

- 1. Create a source directory from which to install.
- 2. Edit the installation configuration file.
- **3.** Run Setup from the command line.
- 4. If you are doing remote installations using SMS, use the SMS Administrator to create a package and install NerveCenter on remote machines.

Follow the instructions in this chapter to do a silent or remote installation of the following NerveCenter components:

Component	Description
NerveCenter Client	Lets you monitor your network, as well as design and manage behavior models.
NerveCenter Administrator	Lets you configure NerveCenter.
NerveCenter Server	Carries out all major tasks, including polling SNMP agents, triggering alarms, and making sure that alarm transitions occur.
Platform Adapters	Integrate NerveCenter with supported network management platforms. (See <i>Network Management Platforms</i> in <i>NerveCenter 4.0.3 Release Notes</i> for a complete list.)
NerveCenter Web support	Integrates NerveCenter with supported Web servers. (See <i>Web Servers</i> in <i>NerveCenter 4.0.3 Release Notes</i> for a complete list.)

Creating a Source Directory

Whether you are doing a single silent installation or subsequent remote installations, you must set up a source directory from which you will install NerveCenter.

TO CREATE A SOURCE DIRECTORY

1. Create a directory to use as the source directory.

Create the directory either on the host machine on which you are installing or on a system that is accessible to and shareable with that host. For example, create a directory called D:\ncsetup and share it as ncsetup.



If you are going to use SMS to do a remote installation, this directory must either be on the SMS host machine or on a system that is accessible to and shareable with the SMS host.

2. Copy all the files and directories from the NerveCenter CD-ROM NT directory to the directory you just created.

After you have copied the installation files to the source directory, you can edit the installation configuration file.

Editing the Installation Configuration File

Whether you are doing a silent or remote installation, you must edit the installation configuration file, setup.iss. This file lets you specify any configurable NerveCenter option.

If you are enabling SNMP v3 traps, check the Services applet in the Windows Control panel to make sure that the MS Trap Service or the OV Trap Service is stopped and disabled.

TO EDIT THE INSTALLATION CONFIGURATION FILE

- 1. From the source directory, open setup.iss in a text editor.
- 2. Edit the file, specifying your configuration options.

CAUTION

If you plan to use SMS to install NerveCenter onto more than one system, make sure that the settings in the setup.iss file are valid for all those installations. You may need to create separate install packages for variations of the installation procedure, such as the NerveCenter Client only on a system.

The configuration options are similar to the options you specify in the Setup GUI. See *Running Setup on Windows* on page 25 for more details.

Running Setup from the Command Line

You can run Setup from the command line, using the values in the configuration file you edited.

TO RUN SETUP FROM THE COMMAND LINE

- 1. If NerveCenter is already installed on this machine, stop all NerveCenter and Wind/U processes. See *Upgrading NerveCenter*.
- 2. If NerveCenter is already installed on this machine, back up any files that you have customized for your business or your environment. See *Upgrading NerveCenter*.
- 3. From a DOS prompt, navigate to the installation source directory you created.
- 4. Type the following command; then press Enter.

setup -s

In the Task Manager, you can tell the installation is complete when the **_INSO432._MP** process stops running. View messages generated during the installation in the ncsetup.log file in the newly-installed NerveCenter directory.

After you run setup from the command line, you still need to set up the NerveCenter database. For more information, see Chapter 4, *Setting Up the Database on Windows*.

After you set up the database, you must restart your computer for NerveCenter to activte properly.

Installing NerveCenter Remotely

After you have create the source installation directory and edited the configuration file, you can create an SMS package and install that package on other machines remotely.



The following procedures give the NerveCenter-specific information for using SMS with NerveCenter. You must already be familiar with SMS. Microsoft provides complete SMS documentation; see the Microsoft Systems Management Server documentation for details.

TO INSTALL NERVECENTER REMOTELY

- 1. Create a new SMS package for NerveCenter by doing the following:
 - a. From the SMS Administrator toolbar, select the Open Window: Packages button. The Packages window appears.
 - b. Select the New button to display the Packages Properties dialog box.
 - c. Select **Import** to display the File Browser dialog box.
 - d. Navigate to your package source directory and select NCSetup.pdf, then select OK.
 - e. In the Package Properties dialog box, select **Workstations** to display the Setup Packages for Workstations dialog box.
 - f. In the **Source Directory** box, specify the server and sharename of the package source directory, and select **Close**.
 - g. Select **OK** again when prompted for confirmation.

The new package is displayed in the Packages window.

- 2. Using the SMS Administrator, create a Run Command On Workstation task to install NerveCenter on a specified drive on specified SMS computers by doing the following:
 - a. From the SMS Administrator toolbar, select the **Open Window: Jobs** button.

The Job window appears.

- **b.** Select the **New** button to display the Job Properties dialog box.
- c. Select **Details** to display the Job Details dialog box.
- d. In the **Job Target** area, specify the SMS computer (in the Machine Path field) or machine group (in the Machine Group field) on which NerveCenter should be installed.

Note <u>Note</u>

The destination machine must be part of the SMS database.

e. Make sure the **Run Workstation Command** box is checked, and select the **Install NerveCenter** command.

When you close the Job Properties dialog box, the task is set to run. When the task completes, the specified NerveCenter components will be installed on the specified drive and directory on all target computers.

Creating your Database from the Command Line

Instead of using the wizard, you can create or modify your database from the command line.



You cannot connect to a NerveCenter 3.6 or 3.7 database without first upgrading the database to version 3.8. For more information, refer to *Upgrading NerveCenter*.

Whether you are doing a silent or remote creation of your database, you must edit the database configuration file, InstallDB.idb. This file lets you specify the information necessary for creating a database.

TO EDIT INSTALLDB.IDB FOR AN SQL SERVER DATABASE

You need to provide all required information about the destination server and your options to InstallDB.

Revise the contents of InstallDB.idb, located in the *installation*/**DB** directory, as follows, substituting the names for your server, user ID, database, and so on. For a review of the options, see *Creating a SQL Server Database* on page 49.

You must specify the default serialized database file, NCExport.asc. This will set up default values in your new database.

Once you edit the InstallDB.idb file, you can run InstallDB.

TO CREATE YOUR DATABASE FROM THE COMMAND LINE

- 1. From a DOS prompt, navigate to the *installation*\nervecenter\bin directory.
- 2. Type the InstallDB command with the appropriate parameters, then press Enter.

Configuring the Database Remotely

You can use SMS with a configuration file of preference settings to install the NerveCenter database from a remote machine.

If you have not already done so, you'll need to install NerveCenter either on the SMS host machine or on a system that is accessible to and shareable with the SMS host. The files you will use in the following procedure are set up during the installation process.

To create an SMS package on the SMS host that can be used to perform remote database installations

- 1. If NerveCenter is running on the server that's your intended database destination, bring NerveCenter down.
- 2. Create a new directory in the NerveCenter directory structure on your SMS host to contain all files required for this process. The directory must be shareable on a host that the SMS server can access. For example, you could create a directory called InDB under Sms.
- 3. Copy the following files to your new directory:

From the NerveCenter **Bin** directory:

- InstallDB.exe
- SerializeDB.exe
- NCPerl*.dll

From the NerveCenter **Db** directory:

- NCScript.sql
- InstallDB.idb
- *Database*.asc (substitute the name of your exported database file, NCExport.asc, for example)

From the NerveCenter Sms directory:

- InstDB.bat
- InstallDB.pdf

These files are in directories set up as a result of the NerveCenter installation. They are not accessible from the NerveCenter CD-ROM.

4. Edit InstallDB.idb.

5. Edit InstDB.bat.

You need to modify the parameters for the **installdb.exe** command to specify the operation type, and database type. See *Creating your Database from the Command Line* on page 76 for a description of the command-line options.

6. Use the SMS Administrator to create a new package and to import the InstallDB.pdf file.

Your new database and data source are created on the destination server based on the contents of your exported database file name.

Configuring NerveCenter Remotely

You can use the utility ImportUtil.exe to copy Server configuration information to a NerveCenter Server.

If you have not already done so, you'll need to install NerveCenter either on the SMS host machine or on a system that is accessible to and shareable with the SMS host. The files you will use in the following procedure are set up during the installation process.

To create an SMS package on the SMS host that can be used to perform remote database installations

- 1. Create a new directory in the NerveCenter directory structure on your SMS host to contain all files required for this process. For example, you could create a directory called ImpUtil under Sms.
- 2. Copy the following files to your new directory:

From the NerveCenter Bin directory:

• ImportUtil.exe

From the NerveCenter Sms directory:

- ImpUtil.ini
- ImpUtil.pdf

These files are in directories set up as a result of the NerveCenter installation. They are not accessible from the NerveCenter CD-ROM.

3. Edit ImpUtil.ini.

Doing Silent and Remote Installations on Windows

ImpUtil.ini is the name of the file containing the Server configuration information and definitions. See *Reconfiguring a NerveCenter Server from the Command Line* in *Managing NerveCenter* for more details.

4. Use the SMS Administrator to create a new package and to import the ImpUtil.pdf file.

Removing Open NerveCenter

Removing NerveCenter includes removing the NerveCenter configuration information from your network management platform (unless you are running NerveCenter as a standalone network management application) and then removing the NerveCenter applications. See Integrating *NerveCenter with a Network Management Platform* for details about reconfiguring your network management platform.



▲ CAUTION

You must be logged in as root (UNIX) or an administrator (Windows) to remove NerveCenter from a machine.

You can remove one or more of the NerveCenter applications by running a simple script that deletes the appropriate NerveCenter files, executables, and directories.

If NerveCenter was integrated with a network management platform, you must have reconfigured your network management platform before you uninstall the software. See *Integrating NerveCenter with a Network Management Platform*.

TO REMOVE NERVECENTER FROM A UNIX MACHINE

- 1. If you haven't done so already, shut down all NerveCenter processes.
- 2. Navigate to *install_directory*/nc/install.
- 3. Type the following and then press Enter:

./uninst.sh

The script begins to run.

- 4. Press Enter as instructed by the script until you reach the prompt that lists the components you can remove.
- 5. At the following prompt, type the letter for each component you want to remove (separating each letter with a space) and then press Enter.

```
Enter your choice [1]
```

6. If you have platform integration installed, type the letter for each platform integration component you want to remove (separating each letter with a space) and then press Enter.

```
Enter your choice [1]
```

7. If you are removing the server but you want to keep your database, type **y** at the following prompt and press Enter.

Do you want to retain the database? [n]

8. If you are removing the server but you want to keep your MIB, type **y** at the following prompt and press Enter.

Do you want to retain MIB? [n]

9. If you are removing the server but you want to keep your log files, type **y** at the following prompt and press Enter.

Do you want to retain the log files? [n]

NOTE NOTE

If you did not shut down all NerveCenter processes, the script lists them, then quits. If that happens, you must kill the processes, then rerun UNINST.SH.

The script lists the files it deletes.

10. To delete the directory, press Enter at the following prompt.

Deleting directory : /opt/OSInc. Continue? [y]

The script completes.

- **11.** If you manually set up any environment variables to point to the NerveCenter installation directory, change them to point somewhere else.
- **12.** If you are removing NerveCenter from this machine completely, delete the neusers and neadmins users and groups, including the nervectr user.
- **13.** If you are removing NerveCenter web support completely and the Web server is on a different machine, reconfigure the server to remove references to NerveCenter. See *Managing NerveCenter Web Integration* in *Managing NerveCenter* for details.

- **6.** If unInstallShield was not able to remove all of the files, open the NerveCenter directory and evaluate whether you want to keep the files.
- 7. If you had a SQL database, do the following on SQL Server: delete or clear the SQL database, delete the data and log devices used with the database, and delete the files used by the data and log devices.

8. You may want to manually remove current user entries that are not automatically removed from the registry. However, if you remove them and then reinstall later, users will have to reconfigure their autoconnect preferences, filter settings, and so on.

Windows Installation Checklist

- □ The machines on which I am installing meet the system requirements (see the *Release Notes*).
- □ If I am upgrading, I have read Upgrading to NerveCenter 4.0.
- □ If I am upgrading and have an Access database, I have serialized my database before removing my old version of NerveCenter.
- □ I am logged in as Administrator or as a member of the Administrators group.

You may use the Software and related documentation on only as many servers as you have purchased licenses.
- 1.11. "Affiliate" shall refer to any legal entity (such as a corporation, partnership, or limited liability company) that is controlled by Customer. For purposes of this definition, "control" means (i) beneficial ownership of at least fifty percent (50%) of the voting securities of a corporation or other business organization with voting securities or (ii) a fifty percent (50%) or greater interest in the net assets or profits of a partnership or other business organization

without voting securities.

1.12. **"Specifications"** shall refer to OpenService's specifications for particular Software applications in effect on the date of the applicable Order Form.

2. GRANT OF LICENSE

- 2.1. License Grant. Subject to the terms of this Agreement, OpenService grants to Customer a nonexclusive, nontransferable license under OpenService's intellectual property rights: (i) to use the Software and Custom Developments, if any, for Customer's internal business purposes in connection with the number of Modules and number of Devices for which license fees have been paid and at the locations specified on the Order Form; (ii) to have system integrators implement the Software for the Customer; and (iii) to make one copy of the Software and Custom Developments including related documentation for archival purposes. OpenService agrees to provide cold and hot back-up copies of Software as listed on its then current price list. Customer acknowledges that that certain Software applications may include "copy lock" protection and/or require an "enabling key," which shall be provided to Customer by OpenService or its licensors for purchased licenses. This is a license agreement and not an agreement for sale. All rights not specifically granted will be reserved to OpenService and its licensors.
- 2.2. **Compliance.** On request, Customer will provide OpenService with a written statement, certified by an authorized representative of Customer, listing the number and type of Devices in use and under management in connection with the Software and any changes to the location of the Software. During the term of this Agreement and for three (3) years thereafter, OpenService will have the right, no more than once annually, to conduct and/or direct an independent accounting firm to conduct, during normal business hours and on reasonable notice, an audit of the appropriate records of Customer to verify this information. If the information supplied by Customer to OpenService proves to be inaccurate by more than five percent (5%) to OpenService's detriment, then the Customer will pay all costs of the audit as well as applicable license and support fees on a retroactive basis.

3. LICENSE RESTRICTIONS

- 3.1. **Restrictions.** Customer will not modify, translate, reverse engineer, decompile, disassemble or otherwise attempt to derive source code, or create derivative works based on the Software or Custom Developments, provided that, if required under applicable law, upon Customer's request, OpenService will provide information necessary for Customer to achieve interoperability between the Software or Custom Developments and other software for a nominal administrative charge. Customer may only use the embedded programs of OpenService's licensors with and as a part of the Software and/or Custom Developments and is prohibited from using such embedded programs for application development purposes or otherwise outside the scope defined in Section 2.1 of this Agreement.
- 3.2. **Third Parties.** Customer will not: (i) host the Software and/or Custom Developments for access by any third party; (ii) rent, lease, sublicense, or otherwise distribute the Software and/or Custom Developments to any third party; (iii) offer the Software and/or Custom Developments in connection with timesharing, facility management, or service bureau usage; or (iv) use the Software and/or Custom Developments to develop or modify applications or perform other programming tasks on behalf of Customer or any third party.
- 3.3. **Proprietary Markings.** Customer agrees to respect and not to alter, remove or conceal any patent, copyright, trademark, government restricted rights, trade name or other proprietary marking that may appear in connection with the Software or Custom Developments.

4. DELIVERY AND LICENSE KEYS

- 4.1. **Delivery; Updates.** Promptly after the Effective Date, OpenService will deliver to Customer one copy of the Software either electronically or on compact disk, at Customer's election, and related documentation. OpenService will also make available to Customer one copy of any Updates, if and when available, either electronically or on compact disk, pursuant to Annual Support Services.
- 4.2. License Keys. Customer acknowledges that the Software needs to be activated by identification codes. Customer will receive its license key through OpenService's website or FTP site using the unique license number provided

to Customer in the Order Form.

5. PAYMENT

- 5.1. **License Fee.** In consideration of the licenses granted and Services provided under this Agreement, Customer agrees to pay OpenService the license and Services fees specified in each Order Form according to the payment terms therein. Concurrently with the execution of this Agreement, Customer will place a binding initial order for Software using the Order Form.
- 5.2. **Taxes.** Customer will pay all taxes (except taxes based on OpenService's net income) and customs duties, however designated, on amounts payable to OpenService.
- 5.3. **Payment.** Customer will pay OpenService for all Software and Services in U.S. Dollars within thirty (30) days of invoice.

6. WARRANTY AND DISCLAIMER

- 6.1. **Warranty.** OpenService warrants for thirty (30) days following delivery that: (i) the Software will operate substantially in accordance with the Specifications, provided that the Customer uses the Software in accordance with the Specifications (including without limitation recommendations for best practices in regard to Software configuration) and documentation and does not modify the Software; and (ii) the media on which the Software is delivered will be free from defects in workmanship.
- 6.2. **Sole Remedies.** In the event the Software fails to perform as warranted in Section 6.1(i) and Customer advises OpenService in writing of a reproducible error within the warranty period, OpenService will use commercially reasonable efforts to correct any defect in the Software. In the event that OpenService is unable to correct a defect within a reasonable time, Customer may return the Software and obtain a refund of any prepaid license fees. In the event the Software fails to perform as warranted in Section 6.1(ii), OpenService will replace the defective disk or other media. This Section 6.2 sets forth Customer's sole remedy, and OpenService's sole obligation, relating to performance of the Software and for breach of the warranties in Section 6.1.
- 6.3. **Disclaimer.** Except for the warranties in section 6.1, to the maximum extent permitted by applicable law, the software, custom developments and the services are provided by OpenService and its licensors without express or implied warranty of any kind, including without limitation, any warranty of merchantability, noninfringement or fitness for a particular purpose. OpenService specifically does not warrant that the software and/or custom developments will meet all of customer's requirements; that the operation of the software and/or custom developments will be error-free or uninterrupted; or that all errors or defects in the software will be corrected. Some jurisdictions do not allow the exclusion of implied warranties so the above exclusions may not apply to customer. This warranty gives customer specific legal rights. Customer may also have other rights that vary from jurisdiction.
- 6.4. Ultra-Hazardous Activities. The software and/or custom developments are not designed, manufactured or intended for use in any environment in which the failure of software could lead to death, personal injury, or severe physical or environmental damage, including without limitation, in the design or operation of nuclear facilities, aircraft navigation or communication systems, air traffic control, direct life support machines, weapons systems or in the on-line control of equipment in any hazardous environment requiring fail-safe performance ("ultrahazardous activities"). OpenService and its licensors specifically disclaim any express or implied warranty of fitness for ultrahazardous activities. Customer represents and warrants that customer will not use, or allow others to use, any software or custom development for such purposes.
- 6.5. **Third Party Software and Materials.** Under no circumstances will OpenService, its affiliates or their respective officers, directors or employees be liable for any damages arising from Customer's use of any embedded programs, other software or materials developed or manufactured by OpenService licensors or other third parties, whether or not such programs, software or other materials were provided by OpenService hereunder. OpenService's only obligation to Customer will be to assign to Customer the indemnity, if any, that OpenService received from the third party licensor, if such indemnity is assignable. Customer is responsible for compliance with third party software license agreements.

7. OPENSERVICE INDEMNIFICATION.

7.1. Indemnification. OpenService will indemnify and defend Customer from any damages awarded against Customer by a court or other tribunal from which no appeal can be or is taken, or from final settlement to which OpenService has consented, arising out of any claim, action or suit ("Claim") that the Software infringes in the United States a patent, copyright or trade secret of any third party, provided that: (a) Customer notifies OpenService promptly in writing if any such Claim is threatened or brought; (b) OpenService has the right to assume the sole defense of such Claim with counsel selected by OpenService; (c) Customer cooperates in the defense or settlement of such Claim as reasonably requested by OpenService, at OpenService's expense; and (d) OpenService has the option at its own expense and in its sole discretion, at any time with respect to any Claim threatened or brought, or any such determination of infringement, to: (i) procure for Customer the right to continue licensing such Software; (ii) replace or modify such Software so that it is non-infringing; or (iii) terminate this Agreement as to such Software, and upon return of the Software by Customer, refund pro rata any prepaid fees for such Software, based on three-year straight-line depreciation. OpenService will have no liability for costs incurred or settlements made without its consent. OpenService will have no liability for any Claim based on modification of the Software other than by OpenService, the use of a superseded release of Software if the infringement would have been avoided by the use of a current release made available to Customer, or use of the Software other than ordinary use in accordance with the Specifications, documentation and this Agreement. This Section states OpenService's entire obligation, and Customer's sole remedy, with respect to any Claim, brought or threatened, or any such determination of infringement.

8. LIMITATION OF LIABILITY

- 8.1. Limitation of Liability. To the maximum extent permitted by applicable law, the maximum cumulative liability of Customer and OpenService and its licensors for damages, to the other party hereunder, regardless of the form of legal action, whether in contract or in tort, including without limitation negligence, will in no event exceed the amount of fees paid by Customer under this Agreement, and if such liability relates to particular Modules or Services, the maximum liability will be limited to the payments received by OpenService for the particular Software application or Services that gave rise to the liability, except that no limitation on damages will apply to losses due to Customer's breach of the license or license restrictions, Section 12.9 (Export Control) or its warranty in Section 6.4 (Ultra-Hazardous Activities), or for either party's breach of Section 11 (Confidential Information).
- 8.2. No Consequential Damages. To the maximum extent permitted by applicable law, in no event will either party or OpenService's licensors be liable under this agreement for special, incidental, indirect or consequential damages, including, but not limited to, loss of profits, loss of revenue, loss of use or loss of data, even if advised of the possibility thereof, or, if reasonably foreseeable, incurred by the other party or claimed against the other party by any third party, except that no such limitation on damages will apply in the event of a breach by customer of the license or license restrictions, section 12.9 (export control) or its warranty in section 6.4 (ultrahazardous activities), or for either party's breach of section 11 (confidential information).

9. SERVICES

- 9.1. Services. In connection with the implementation, support and use of the Software by Customer, OpenService will provide Services to Customer as applicable at the rates specified in each Order Form under the terms of this Agreement.
- 9.2. **Ownership of Intellectual Property.** If Customer suggests any new features, functionality or performance for the Software that OpenService subsequently incorporates into the Software, such suggestions will be free from any confidentiality restrictions that might otherwise be imposed upon OpenService pursuant to Section 11 (Confidential Information). OpenService will own and Customer hereby agrees to assign and assigns to OpenService all right, title, and interest in the copyright, patent, trade secret and all other intellectual property rights that may be conceived, reduced to practice, created or developed by OpenService or Customer in the performance of Services under this Agreement, including without limitation Custom Developments and such Customer suggestions.

- 9.3. Future Activities. Customer acknowledges that OpenService and its employees, consultants or subcontractors may from time to time perform services for others or incorporate functionality in its Software that are similar or identical to Services performed for or a Custom Development created for Customer under this Agreement. So long as no Confidential Information of Customer is disclosed, OpenService will not be restricted in any way from developing or providing to others software, forms, materials, methodologies, modifications or services which are similar or identical to Services performed for, or Custom Developments created for, Customer, or be restricted in its use of personnel providing Services hereunder.
- 9.4. **Payment for Services.** OpenService reserves the right to discontinue the provision of any and all Services if payment is not received in accordance with the terms of this Agreement or any Order Form.
- 9.5. Reimbursement. Customer will pay or reimburse to OpenService all reasonable travel, accommodation and other out-of-pocket expenses incurred by OpenService, its employees, consultants or subcontractors in connection with OpenService's provision of Professional Services under this Agreement.
- 9.6. **Compensation on Termination of Services.** In the event of any termination of Services prior to completion, payment will immediately be due for performance rendered up to the effective date of such termination and for non-cancelable commitments, including expenses.

10. TERM; TERMINATION

- 10.1. **Term.** This Agreement will be effective from the Effective Date and will continue perpetually with respect to the Software licenses unless terminated in accordance with the provisions of this Section 10.
- 10.2. **Termination.** Upon any material breach of this Agreement by either party, the other party will have the right to terminate this Agreement and the licenses granted hereunder effective on thirty (30) days' notice; such termination will become automatically effective unless the breaching party has cured any material breach prior to the expiration of the thirty-day period. OpenService will also have the right, effective on notice, to immediately terminate this Agreement and the licenses granted hereunder if Customer: (i) files a petition in bankruptcy or insolvency, or for reorganization or the appointment of a receiver or trustee, (ii) is served with an involuntary petition against it in any insolvency proceeding that is not be dismissed within sixty (60) days after filing, (iii) makes an assignment for the benefit of creditors, or (iv) breaches Sections 2 (License Grant) or 3 (License Restrictions) of this Agreement.
- 10.3. Consequences. In the event of termination of this Agreement for any reason, Customer will promptly (i) discontinue all use of the Software and Custom Developments; (ii) erase or destroy any Software and Custom Developments contained in the computer memory or data storage apparatus; (iii) return to OpenService or destroy all copies of the Software, Custom Developments and OpenService Confidential Information; and (iv) certify in writing to OpenService, within thirty (30) days of termination of this Agreement that Customer has complied with the foregoing.
- 10.4. **Survival.** Termination of this Agreement will not limit either party from pursuing other remedies available to it, including injunctive relief, nor will termination relieve Customer of its obligation to pay all fees that have accrued or are otherwise owed by Customer under any Order Form. Prepaid fees are nonrefundable unless otherwise expressly provided in this Agreement. Sections 1, 2.2 (survives for three (3) years), 6.2, 6.3, 6.4, 6.5, 8, 9.2, 9.3, 10.3, 10.4, 11 and 12 hereof will survive expiration or any termination of this Agreement.

11. CONFIDENTIAL INFORMATION

11.1. **Confidential Information.** Each party may have access to confidential information of the other party, including without limitation, Software, Custom Developments and training materials (if any), and all other information that is identified in writing as confidential at the time of disclosure ("Confidential Information"). Each party agrees that it will use Confidential Information only in the performance of this Agreement and for no other purpose, will not disclose such Confidential Information to any third party (except as required by law or to that party's attorneys, accountants or other fiduciary advisors as reasonably necessary), and will take reasonable precautions to protect the confidential Information only to those employees who have a need to have access solely

for the performance of this Agreement and taking measures by instruction and agreement prior to disclosure to such employees to protect against unauthorized use or disclosure.

11.2. **Exclusions.** Confidential Information will not include information that: (i) is rightfully received by the receiving party from a third party without an obligation of confidentiality; or (ii) was publicly known at the time of disclosure to receiving party or becomes publicly known through no act or omission of the receiving party. If any Confidential Information is required to be disclosed by a judicial or governmental order, the receiving party will promptly notify the disclosing party and take reasonable steps to assist in contesting such order or in protecting the disclosing party's rights prior to disclosure.

12. GENERAL

- 12.1. **Provision of Notice.** Any notice given hereunder will be in writing and delivered by courier service or mailed by pre-paid registered mail, return receipt requested, addressed to the other party at the address on the Signature Cover Page. Any notice so delivered will be deemed to have been received by the addressee at the time and date when actually delivered or in any event within ten (10) days after sending in the manner provided. A party's notice address may be changed at any time effective on notice.
- 12.2. Assignment. Customer may not assign this Agreement or any rights or obligations arising under this Agreement without the prior written consent of OpenService, such consent not to be unreasonably withheld; provided, however, that such consent shall not be required if Customer assigns to an Affiliate, unless the Affiliate is a direct competitor of OpenService. OpenService may assign this Agreement and any rights or obligations hereunder. This Agreement will be binding on the successors and permitted assigns of the parties.
- 12.3. **Waiver.** The failure of either party to enforce in any one or more instances any of the terms of this Agreement will not be construed as a waiver of future performance of any such term. Waiver of any term will only be deemed to have been made if expressed in writing by the party granting the waiver.
- 12.4. **Severability.** If any provision of this Agreement is held by a court or other tribunal of competent jurisdiction to be illegal, invalid or unenforceable, that provision will be reformed, construed and enforced to the maximum extent permissible, and the remaining provisions will remain in full force and effect.
- 12.5. **Governing Law.** This Agreement will be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts, without regard to its conflict of law principles. Subject to Section 12.6 (Arbitration), each party hereby irrevocably submits to the exclusive venue and jurisdiction of any federal or state court sitting in Boston, Massachusetts in any action, suit or proceeding brought against it by the other party under this Agreement. The UN Convention on Contracts for the International Sale of Goods does not apply.
- 12.6. **Arbitration.** The parties agree to submit any dispute arising under this Agreement (excluding disputes arising out of or relating to intellectual property) to binding arbitration in Boston, Massachusetts, under the then current Rules of Arbitration of the International Chamber of Commerce by one arbitrator appointed in accordance with said Rules. Judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction. Notwithstanding the foregoing, at any either party may apply for injunctive or other temporary relief without breach of this arbitration provision.
- 12.7. Entire Agreement. This Agreement constitutes the entire understanding between the parties, and supersedes all prior discussions, representations, understandings or agreements, whether oral or in writing, between the parties with respect to the subject matter of this Agreement. The terms of this Agreement will have no force or effect with respect to any claim based on the use of the Software outside the scope of the licenses and rights expressly granted herein. The preprinted provisions of Customer's purchase order will not apply, and the provisions set forth herein will prevail. In the event of any conflict between the terms of these Standard Terms and Conditions and the terms set forth on any Order Form or any other Schedule, the terms of these Standard Terms and Conditions will prevail, unless expressly provided otherwise. Any amendment to this Agreement must be in writing and signed by an authorized representative of each party.
- 12.8. **U.S. Government Restricted Rights.** In the event that Customer is an agency of the United States Government, or that the license granted hereunder is pursuant to a contract with either a defense or civilian agency of the

United States Government, Customer agrees that the Software is provided with restricted rights. Use, duplication or disclosure by the Government is subject to the restrictions as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or the restrictions set forth in subparagraphs (c)(1) and (2) of the Commercial Computer Software Restricted Rights clause at 48 CFR 52.227-19, as applicable, or in successor provisions, as well as the limitations set forth herein. Manufacturer is OpenService, Inc., 110 Turnpike Road, Suite 308, Westborough, MA 01581.

- 12.9. **Export Control.** Customer acknowledges that it is subject to United States laws and regulations controlling the export of technical data, computer software and other commodities and agrees not to export or allow the export or re-export of such data, software or other commodities in violation of such laws and regulations.
- 12.10. **Independent Contractors.** The parties to this Agreement are and will remain independent contractors. Nothing herein will be construed to create a partnership or joint venture between them, and neither will have the power or authority to bind or obligate the other in any manner not expressly set forth herein.
- 12.11. **Headings.** The headings used in this Agreement are for ease of reference only and will not be used to interpret any aspect of this Agreement.
- 12.12. **References.** All references in this Agreement to the "sale" or "purchase" of Software or Custom Developments means the granting or obtaining of certain license rights to use such software.
- 12.13. Force Majeure. Neither party shall be in default of its obligations (other than the payment of money) to the extent its performance is delayed or prevented by causes beyond its reasonable control, including without limitation, acts of God, earthquake, flood, embargo, riots, sabotage, utility or transmission disruption, failure or delay of suppliers, fire or labor disturbances.
- 12.14. **Press Releases; Use of Name.** OpenService may issue one or more press releases relating to the business relationship created by this Agreement and may use Customer's name in its general customer list in print and website materials.
